Come earlier or stay later to tour or conduct research and receive a 15% discounted rate per night. To make your reservation at the special rate, contact the hotel at 703-979-4400 and identify yourself as part of the "Hull Family Association." Individual reservations will be accepted immediately. Rooms are available with king-size bed (1–2 persons) or 2 queen-size beds (up to 4 persons). King rooms come equipped with a microwave and small refrigerator. Queen rooms have neither. The motel has outside entrances and is on two floors without elevators. First floor rooms will be available for all who request them. Free shuttle service to Reagan National Airport and nearby huge shopping mall and Metro station. Free parking and free continental breakfast is included in room rate.

The reunion registration fee is \$15 **per person**. Dinner and Hull Extravaganza at the Best Western on Friday is \$30.00 **per person** and the picnic on Saturday at a covered pavilion is \$15.00 **per person**.
